About Yangling District, Shaanxi Province

Yangling is a district of Xianyang City, Shaanxi province, People's Republic of China, located on the plains of the Wei River. It has an area of 94 square kilometers and a population of 200,000. The district is roughly 80 kilometers to the west of Xi'an, the provincial capital city. Starting in 1979, Yangling went through several administrative region changes until it became a district to the City of Xianyang in 1983. Yangling Agriculture Hi-Tech Industrial Zone was approved as a national-level hi-tech development zone by State Council in 1997.

4000 years ago, the ancestor of China's agriculture called Houji taught people to grow crops here, making Yangling the birthplace of China's agricultural civilization. Yangling received its name as the family burial site of founding emperor Yang Jian of the Sui Dynasty. In 1934, the National Northwest College of Agriculture and Forestry (the processor of Northwest A&F University) was founded here by senior official Yu Youren and compatriot Genaral Yang Hucheng. Since the foundation of People's Republic of China in 1949, the central government and provincial government have successively established 2 agricultural colleges, 5 independent agricultural and forestry research institutes and 3 provincial key secondary agricultural schools. Therefore, Yangling is called China's "Agro-science City". Yangling is now the cradle of China's agricultural science and technology development and a significant base for the demonstration of agricultural industries.

The average temperature of Yanglin in October is from 10° C to 20° C.

Invited Speakers

Paul Dorosh

Paul Dorosh is the Division Director of the Development Strategy and Governance Division, IFPRI. He worked at the World Bank from March 2003 to August 2008 as a Senior Economist with the Spatial and Local Development Team of the Finance, Economics and Urban Development Unit (2007-08) and Senior Rural Development Economist of the South Asia Rural and Agricultural Development Unit (2003-07). He has published research on agricultural markets, food policy, international trade, economy-wide modeling and the rural-urban transformation. He holds a Bachelor's Degree in Applied Mathematics from Harvard College, Cambridge, Massachusetts, and a Master Degree and Doctorate Degree in Applied Economics from the Food Research Institute, Stanford University, USA.

Minjuan Zhao

Minjuan Zhao is the professor and Associate Dean of College of Economics and Management in Northwest Agricultural and Forestry University. Her research focuses on Environmental and Natural Resource Economics, Applied Microeconomics and Regional Economics. She got her PhD from Department of Agricultural and Natural Resource Economics, University of Connecticut, 2009. She once worked as a Visiting Scholar at Department of Agricultural &Natural Resources Economics in University of Guelph, Canada from 2003 to 2004.

Juwei Zhang

Junwei Zhang is the senior researcher and Deputy Director at Institute of Population and Labor Economics in Chinese Academy of Social Sciences. His research interests are labor economics and development economics. He participated in the doctoral training courses in Economics for the LEAD21 Program at China Agricultural University, sponsored by Winrock International and earned a certificate from 1996 to 1998. During 1994 to1995, he got the Postgraduate diploma in Population and Development at Center for Development Studies, Trivandrum, India. He got his PhD in demographic economics at Graduate School of Chinese Academy of Social Sciences in 2001.

Hans Binswanger

Hans Binswanger is the Adjunct Professor of College of Economics and Management, China Agricultural University. He got his PhD in Agricultural Economics at North Carolina State University in 1973. He was the Senior Advisor, Africa Region, World Bank from 2003 to 2004. He was the Director for Environmental, Rural, and Social Development, Africa Region in World Bank from 1996 to 2002. He has assisted a number of countries in the development of agricultural and rural development strategies and in the design of community-driven development programs and HIV/AIDS programs.

Fusuo Zhang

Fusuo Zhang is a professor and "Yangtze River Scholar" in China Agricultural University. He received his Ph.D. in Plant Nutrition from Hohenheim University (Germany). His past appointments include President of International Plant Nutrition Council, vice President of Soil Science Society of China, vice President of Plant Nutrition and Fertilizer Science Society of China, vice President of Nature Resource of China, and Chairman of Soil testing and fertilization expert committee, Depart of Agric. China. His research is focused on rhizosphere dynamics, plant nutrient mobilization and uptake and nutrient management in agro-ecosystems. Since 1998, he has focused on developing integrated nutrient management concept and techniques to realize high yield and high-efficiency crop production system through improving soil fertility, nutrient use efficiency and crop yield and quality, and reducing environmental pollution for main crops in China.
